LIAISON MEETING WITH TAYLOR WIMPEY - NORWICH RD/CHURCH LANE HOUSING DEVELOPMENT

After another productive liaison meeting with Taylor Wimpey the following information may address issues on the new building site:

The main road through the new development in narrow but actually it is 6 metres wide compared with current Church Lane 5.3 metres and Thornhill Road at 5 metres. Church Lane will not be closed for at least 3 years (hopefully not until end of build in 2028) and the bollards stopping access will be above the Thornhill Road junction. So, from Norwich Road you can go up Church Lane to Thornhill Road but not as far as the Church. Traffic down Church Lane from above the Church will have to go through the new development.

COMMUNITY SPEED WATCH VOLUNTEERS WANTED

We are very keen to get Community Speed Watch back up and running but need more volunteers. If you are concerned about speeding in the village and can you spare one or two hours every week or fortnight, get in touch. This will enable frequent speed checks to be conducted in the village with the portable speed camera device. FREE INSULATION

Mid Suffolk District Council has a scheme for free insulation upgrades for homes under a new £2million initiative.

You will need to meet the following criteria to qualify, properties need:

- an EPC rating below a C.
- an annual household income under £60k. Savings of no more than £16k.
- to be in Council Tax bands A-D
- Insulation options must be viable in the property.
